in order to give you an even better feeling of safety, we have additionally extended our Bergblick Corona protective measures. In addition to the use of all disinfection precautions and the mandatory use of masks, we carry out daily temperature checks on all our

Arrival - Stay

As of 05 March 2022, the following restrictions relief will come into force:

In all essential areas, such as gastronomy, hotels and mountain railways in which:

the 3G rule has applied up to now, there will no longer be a requirement to provide proof.

FFP2 obligation still applies in the following areas:

- in public transport vehicles and their stops
- in customer areas of vital trade (supermarkets, drugstores, banks, post offices, etc.)

In all other places there is still an RECOMMENDATION to wear an FFP2 mask in closed rooms.

There is No general curfew

Accommodation establishments/restaurants

- Access to the hotel is only allowed without symptoms
- Disinfection facilities are distributed in all public areas

Distance Regulation:

- The minimum distance of two metres from non-household persons is still recommended.

In case of signs of illness or in case of suspicion

- Before arrival: We ask you to seek medical treatment and quarantine at home.
- During your stay: we ask you to stay in your room and inform us immediately.

Regarding return travel regulations in your home country, we ask you to inform yourself accordingly and to adhere to the applicable measures.
